After the start, the boards FRA 1888, RUS 3, HKG 97, ESP 66, CYP 10, ISR 18, ESP 638, TUR 9999, ESP 369, ESP 399, FRA 379, POL 64, OMA 15, ESP 366, FRA 73, GBR 262, ESP 5, OMA 8, TUR 8911, FRA 1607, RUS 85, GBR 988, ISR 9, GBR 3127, GBR 991, ITA 73, FRA 503, ESP 24, ITA 10, ESP 21, POL 45, GBR 111, TUR 3012, RUS 0 sailed the following course: 1 - 3 - 2 - 3 and then crossed the finishing line. Boards ESP 5, ESP 34, ESP 66, ESP 369, ESP 399, ESP 638, FRA 310, ISR 9, ISR 18, ISR 39, ISR 56, ITA 10, ITA 73, RUS 0, RUS 3, RUS 85 retired after the race.

Conclusion and Rules applicable:
By sailing the outer course, boards CYP 10, ESP 21, FRA 73, FRA 312, FRA 379, FRA 503, FRA 1607, FRA 1888, GBR 111, GBR 262, GBR 988, GBR 991, GBR 3127, HKG 97, OMA 8, OMA 15, POL 45, POL 64, TUR 3012, TUR 8911 and TUR 9999 did not sailed the appropriate course. By retiring after the race boards ESP 5, ESP 34, ESP 66, ESP 369, ESP 399, ESP 638, FRA 310, ISR 9, ISR 18, ISR 39, ISR 56, ITA 10, ITA 73, RUS 0, RUS 3, RUS 85 they took the appropriate penalty.
