**Fact Found:**  
On April 12th at 15:30hs, the RC delegate painted with green marker all the boxes that where not signed on the check-out list. The starting time of the race 9 for the fleet Women silver was 15:55hs. RUS 30 signed in top of the green line on the check-out list. The SI 21.4 states that competitors not racing for any of the racing days shall inform the Race Committee. The SI 21.2.1 states that when going out to race each competitor intending to race shall personally "check out" by signing the check-out form. The point 21.2 is marked as [SP]. The SI 17 Penalty System states that the penalty for broke SI 21.2.1 is 1 point applied to the next race completed even if no race is completed on the day of the infringement. The RC applied 1 point on race 9. RUS 30 started on time and sailed race 9.

**Conclusion and Rules applicable:**  
RUS 30 score has been, through no fault of her own, made significantly worse by an improper action of the race committee therefore she's entitled to redress.
